Lower Lake Youth Football Inc. is a non-profit 501c3 based in Clearlake CA. We provide a league for organized football and cheerleading for our local youth in grades 2-8. We focus on safety first and secondly encouraging and inspiring the kids to love the sport and build confidence in the process. In March of this year, a completely new Board was assigned to the program. The program was handed over without a non-profit, no bank account, in debt to Riddell Helmets for \$7,000.00, and without any historical documentation specific to the previous board. We paid off the debt and started from square one in March. Attached is our IRS letter of 501c3 status.

Section 7.

a. When we took over the league we had to inventory all of our gear. The majority of our helmets were expired and what helmets we could use, most had helmet pads that did not correctly fit the heads of our youth. Safety is our #1 priority with the youth, keep them safe by way of using approved and well fitting equipment as well as knowing how to correctly use their body in the sport. helmets and shoulder pads are the 2 main pieces we use to keep the youth safe, they also happen to be quite expensive. In addition to helmets and shoulder pads, there is a new piece of safety equipment that accompanies the helmet, it is called a Guardian Helmet Cover. These are padded covers that go over a helmet for a player to use during practice to reduce additional impact on the head by 33%. We would love to start using these as quickly as we can, for every kid. Our shoulder pads were also very worn and we did not have enough of each size to properly fit the kids. The helmet and shoulder pads are imperative to their safety

while playing, however having these articles on their bodies while playing in the heat of the season, creates its own issues. While exerting so much energy and effort while in the game we keep water on the side lines. Last year we had times where a few kids did not bring enough water to last throughout the game and kids were showing signs of heat exhaustion. Our coaches have to go through classes on heat exhaustion to be able to recognize the signs and symptoms. We are hoping to add a Game Day Hydration Package to our league. This is a combination of 2 large water cooled fans and a water station that can safely and adequately provide water to 8 players at once, and can be used for all 3 teams (Pee Wee, JV and Varsity) on game days. The fans provide a cooler temperature by 20 degrees for the kids to rest in, and help bring body temps down. These fans are portable and come with warranties. Lastly we hope to purchase more tackle pads and practice equipment. In doing so we can limit the amount of person to person contact during practices as much as possible.

b. During this 2024 funding period our goal with the grant funds is to be able to inventory unexpired helmets, shoulder pads and guardian helmet pads, for the next 2 coming seasons. We also have a goal to make the practice and games as safe as possible for the rest of the league's future. Our coaches take the required classes on tackling, cpr, heat exhaustion and concussions so that they can address issues that arise, by having the right gear and tools available, we hope to prevent any of these issues from ever happening.

Section 7.2

a. The Redbud HCG will benefit from this expenditure by having directly contributed and funded the safety and wellness of over 130 local youth, most of whom come from underprivileged families. These kids will want to be a part of the league, therefore staying active and outdoors for many years of their imperative childhood. Creating positive active habits. Also having the correct equipment and additional resources will keep our players out of the emergency rooms. Lower Lake Youth Football Inc. will also announce at all home games the generosity of the Redbud HCG, for their contributions.


